There is a new system for recording serious behaviour issues, e.g. bullying, with concerns going to one member of staff who then decides in what category it needs to be recorded. The Chair asked VER to give governors more details concerning the Raising Attainment Group (RAG). The group meets weekly and reviews the progress of Year 11 and work with the Heads of Departments to support under-performance. Various interventions are then put in place. There are five monitoring points during the year and these are also used by RAG to drive progress.
